

RELEASE OF ALL LIABILITY AND AGREEMENT TO INDEMNIFY AND HOLD HARMLESS

- I hereby waive, release and forever discharge Lanvictims, its organizers, staff and volunteers, from any and all liability to the extent allowed by law for any personal injuries or property damage that one or all of us may sustain as a result of, or during, our participation in any Lanvictims event, including any personal injuries or property damage that I/we believe may have been sustained as a result of the negligence, in whole or in part, of Lanvictims. I/we further agree to indemnify Lanvictims, its organizers, staff and volunteers from any and all claims of any nature whatsoever, including, but not limited to, personal injury and property damage, by any third party or third parties, which they claim are caused, in whole or in part, as a result of any act(s) or conduct, whether unintentional, negligent, or intentional, by one or all of us, which may occur immediately prior to, during, or immediately following any Lanvictims event.
- I/we understand that Lanvictims does not, under any circumstances condone any type of illegal activity whatsoever, including but not limited to the copying of illegal software, MP3's or distribution of pornographic material to minors. Each individual is solely responsible for the files on their machine and the associated copyright laws.
- I/we understand that Lanvictims maintains a strict no smoking indoors, and no illegal drug policy and I/we agree not to bring to any Lanvictims event or distribute at any Lanvictims event any illegal drugs.
- I/we understand that our machine(s) are our personal responsibility and liability and agree to indemnify and hold harmless Lanvictims, its organizers, volunteers and staff from any claims arising out of, in whole or in part, our use in any way of our computers, monitor, or other computer related equipment during any Lanvictims event.
